



## **Galleon Announces \$15.6 Million Financing**

CALGARY, ALBERTA--(Oct. 8, 2009) -

Galleon Energy Inc. ("Galleon") (TSX:GO) announces that it has entered into a financing agreement with an underwriting syndicate co-led by GMP Securities L.P. and Cormark Securities Inc. and including, Scotia Capital Inc., TD Securities Inc., Macquarie Capital Markets Canada Ltd., FirstEnergy Capital Corp., HSBC Securities Canada Inc., Thomas Weisel Partners Canada Inc. and Maison Placements Canada Inc. to act as underwriters on a "bought deal" basis for the sale, on a private placement basis, of 2,000,000 Class A Shares on a flow through basis ("Flow Through Shares") at \$7.80 each for aggregate gross proceeds of \$15,600,000.

Closing is expected to occur on or about October 22, 2009 and is subject to certain conditions including, but not limited to, the receipt of all necessary approvals including the approval of the Toronto Stock Exchange.

The proceeds from the issuance of the Flow-Through Shares will be used to incur eligible Canadian Exploration Expenses which will be renounced to subscribers effective on or before December 31, 2009. Galleon plans to expand the horizontal drilling program and acquire additional seismic data in the successful Doig light oil resource project. Galleon also plans to expand the drilling program in the Montney resource project.

Galleon is a technically oriented oil and gas company with focused operations in the Peace River area of Alberta. Galleon has assembled approximately 1 million gross acres of land and has an inventory of over 1,000 drilling locations.

Galleon has approximately 82.9 million Class A Shares outstanding which trade on the TSX under the symbol "GO".

The Class A Shares issued have not been and will not be registered under the United States Securities Act of 1933, as amended, and may not be offered or sold in the United States, or to a U.S. person, absent registration, or an applicable exemption from the registration requirements.
